Good Morning Brendan and Karin

At our 12 December 2023 meeting on the Migration Strategy implementation, Jobs and Skills Australia (JSA) undertook to provide the Department of Home Affairs with updates on the Core Skills Occupations List (CSOL) project, with reference to the previously circulated JSA Work Plan (Gantt Chart).

Following a 15 February 2024 meeting with Minister O’Connor’s Office (s22 from Minister O’Neill’s Office also attended) we can share the following CSOL documents. Please note these documents are not for wider distribution:

- Draft CSOL (i.e. output of the JSA Migration Labour Market Indicator Model)—for stakeholder engagement purposes, we will release the draft CSOL as “confident on list”; “targeted for consultation” and “confident off list”. The option also exists to release a list of “occupations in scope of international obligations”—this is pending legal and policy advice from the Department of Foreign Affairs and Trade (DFAT).
- CSOL Stakeholder Engagement and Consultation Approach—this document outlines the proposed approach which includes a survey, submissions, bilateral meetings, focus groups and in-depth interviews. Stakeholder engagement will occur over the period March to May 2024.
- JSA Migration Methodology—a public version of this document, including information on the analysis to inform advice on the scope of international obligations, will be released on the JSA website (at Migration Strategy JSA).

We are happy to set up a meeting to discuss the attached documents and next steps.
